EnviroCare Protection Plan

Cover your Envirostall system with our EnviroCare Protection Plan. EnviroCare provides you with confidence in our system and demonstrates our commitment to customer satisfaction.

The health of your horse and a safe environment are our top priorities. As part of the Envirostall family, your exceptional ownership experience starts with EnviroCare, an on-going maintenance plan that assures that your Envirostall system functions effectively and as intended throughout the life of the program. EnviroCare provides you with peace of mind knowing that if any issues or malfunctions arise with the Envirostall system during the program, Envirostall will address and resolve the problem. We take pride in ensuring you and your horse the proper functioning of our system. With EnviroCare, we provide this protection and support for the duration of your participation in the plan. It demonstrates our confidence in the performance of the Envirostall system and our commitment to customer satisfaction.

EnviroCare starts on day one and remains in place as long as the customer is part of the EnviroCare program. Envirostall replaces or repairs any defective or worn parts of the Envirostall system, including the Enviropad, Enviromats, Envirolyte and our proprietary microbes, throughout the program. Envirostall monitors the moisture and air quality in your stalls and works with you to improve your horse stall management practices.

What You Need to Know

Eligibility

Envirostall systems are covered by EnviroCare throughout the term of any lease. Upon completion of the term designated in the lease noted above, the EnviroCare plan is on-going at \$79.00 per month unless terminated in writing by customer(s). Upon termination of the EnviroCare plan, Envirostall LLC will no longer warrant or monitor the installed Envirostall systems, which now become the sole responsibility of the customer(s). Once the EnviroCare plan is terminated, it cannot be reestablished.

What is Not Covered

EnviroCare covers the Envirostall system when it is used as an environmental preservation system in horse stalls. Use of the stalls for purposes other than the boarding of horses will void the EnviroCare coverage. EnviroCare does not cover damages that result from flooding or improper drainage, fire, wind, or other natural occurrence, or if the stalls are not maintained using the proper care and guidance per the on-going monitoring of the stalls by Envirostall LLC. EnviroCare does not cover damages resulting from the use of pellets as bedding in the stall.

Transferability

Coverage can be transferred once, at no cost, from the original owner to a private party purchasing your barn in a real estate transfer. Current owner must inform Envirostall LLC of its intent to transfer the plan to the new owner and cancel their payment option. Envirostall must receive your cancellation request at least 5 business days prior to the 15th of the month to ensure cancellation. The new owner must then submit an Automatic Payment Plan Authorization Agreement with the first payment withdrawn the 15th day of the month following the submission of the agreement. The Automatic Payment Plan Authorization Agreement from the new owner must be submitted in a timely manner as to not miss a payment for the continued coverage of EnviroCare.

Payment

The cost for EnviroCare is \$79.99 per month per stall and must be paid through the Envirostall Automatic Payment Plan. Enrollment in the plan requires the submission of the Envirostall Automatic Payment Plan Authorization Agreement. Payment for EnviroCare shall commence on the 15th day of the month following the one-year anniversary of a paid-in-full installation, or on the 15th day of the month following the end of the lease term as designated on the face of the Lease. All payments by customer(s) during the term of this lease shall be paid through the Envirostall Automatic Payment Plan as defined in the Envirostall Automatic Payment Plan Authorization Agreement.

Cancellation

EnviroCare plan is on-going at \$79.00 per month unless terminated in writing by customer(s). The Lease shall terminate on the last day of the month in which customer(s) makes the final lease payment. Upon termination of the EnviroCare plan, Envirostall LLC will no longer warrant or monitor the installed Envirostall systems, which now become the sole responsibility of the customer(s). Once the EnviroCare plan is terminated, it cannot be reestablished.

Installation Method Effect on EnviroCare

Customer(s) may select the method of installation of the Envirostall system; however, the installation method may affect your EnviroCare plan.

a. If using Envirostall installers - no effect on the EnviroCare plan.

b. Customer-selected professional installer - no effect on the EnviroCare plan if the Envirostall system is installed under the guidance of an Envirostall site supervisor.

Installer must adhere to all Envirostall installation guides and the instructions of the Envirostall site supervisor. Failure to do so could void the EnviroCare service plan.

c. Customer(s) self-installs - no effect on the EnviroCare plan if the Envirostall system is installed under the guidance of an Envirostall site supervisor. Customer(s) must adhere to all Envirostall installation guides and the instructions of the Envirostall site supervisor. Failure to do, or installing the Envirostall system without the guidance of a site supervisor could void the EnviroCare service plan.
